Elevated ICP must be avoided as this may lead to cerebral herniation. It is important, then, to keep CO2 from rising in casualties with injured brains. On the other hand, hypocapnia leads to cerebral vasoconstriction and decreased cerebral blood flow, which can also be bad for the casualty in that it reduces the amount of oxygen supplied to the brain.
