# Brian LaCroix, FACPE, CPPS, NRP (Ret.), (CPS)

- -Strategic planning session first since pre-COVID. This was a positive activity for CPSD finding ways to leverage the resources of expertise of EMS based work in progress.
- -Kathy Ware Exec Director will be at the CPS booth at Pinnacle.
- -Brian will be retiring his CPS position and going fulltime at his consulting group, Cambridge consulting.

# **Eileen Frazer, (CAMTS)**

- Mobile health standards are now available.
- Pennsylvania had a large mobile health checking on patients, or help get them into home health, and now it's been shut down in this state.
- -Calling CMS to share these standards are already in place in other states.
- -Pushing to get these standards out to educate everyone from CMS to the providers.
- -Share the information that there is 2-years' worth of work, and free downloads available.
- -Since COVID they have received many concerns and complaints about "fatigue" from long shifts and it could be the cause of Air/ Pilots and ground driving fatigue causing accidents and forgetting mishaps.
- -Feeling the effects of staffing issues has really taken a toll on compassion, and empathy, and must be reviewed more closely.

# Mike McEvoy, PhD, NRP, RN, CCRN (IAFC)

- -NEMESIS working on a way to report violence against clinicians.
- -Hoping to link this reporting into patient care system to automatically collect data, once areas of interest are selected.
- -Good news it has backing and financial support to move forward.

## Dr. Bryan Wilson, MD, FAEMS (NAEMSP)

- -Baseline work going on and trying to focus on DEI initiatives that circle around quality and safety.
- -Build systems that are endorsed as national organizations and develop, evidence-based metrics and pairing off with actual rural work with quality, due to low critical patient encounters.

- national EMS performance improvement collaborative over lights and sirens has been completed.
- -Next working on the publications; and the change package should be ready for publication in September.

- -Safe streets and roads for all has money still available, help spread the word, applications due by Aug 10 Will roll for another 3 years.
- -CAP with NASEMSO a method of testing child restraint devices in ground ambulances, this is a multiyear agreement.
- -NEMSAC has several advisories coming soon to do with safety, with best practices for using body cameras,

- -EMS response threats,
- -Helicopter landing zone best practices.
- -Establish best practices for EMS and preparing for plan and unplanned large-scaled events.
- -Plus, the ambulance crash data and analysis.
- -Public comments will be opening and is scheduled for August the ninth and tenth registration out soon.
- -EMS and Covid response. White paper are finally published and finally out for public consumption that's available on Ems Gov
- EMS education, agenda 2050. will follow and allow the EMS community to decide what direction they want the EMS education to go. The consensus document is for the EMS education of the future.
- -NHTSA Offices of EMS, EMS Specialists working on projects in disaster prep and EMS education.

- -The regional Highway Safety Office and that tribe and their law enforcement, they added paramedic education as an allowable expense on the law enforcement grants and they can leverage them easier.
- -State level and local level relationship building can really give the ability to leverage these grants.
- There are several regions interested in EMS and 911 programs. Touch base with your state.

- In chat link on published article with colleagues at CDC and NIOSH we looked at 3 years of NBDRS data coded by occupation looking at suicide.
- The public safety module of the NBDRS went live and hoping to start looking at data in about a year.
- -The National Council of State legislatures, Health and Human Service chairs committee meeting met 2 weeks ago.
- -Mental health and safety of our workforce is a very important topic and top priority.

# **GRANT Conversation:**

- -The Grant would be great but it's not a direct grant to EMS, and difficult to find and not an easy sale to EMS agencies.
- -Asking EMS to apply for them, and partner with somebody to be a part of these grants, still too hard to find what is needed.
- -We need help to clarify the location and how to apply.
- -There is a direct grant localities, locals, municipalities, regions and tribes can apply directly for grants and there's no middle person.
- -For other monies available, you must go through your public safety offices, your State public safety offices to get that cash for the other programs that are available.
- -Drill into that website, and you will find the year one awards sorted by state and unit of government name and the local level that got up either a planning grant or an implementation grant.
- -If they got a planning, grant those local EMS agencies in that governmental jurisdiction should run straight to the awardee for Crash care as one of the five components of the safe system approach.
- -Request for creating a one-page document with information and directions on how to dig into the grat materials in an easy step by step process to get funding for the outlined process.
- Great idea to have a one pager, but it's not going to be a simple lift, it will be a complex challenge.
